# METAC Annual Steering Committee Meeting



**METAC** held its Annual Steering Committee meeting on May 19 in Beirut. METAC's strategy for the next funding cycle (May 2016-April 2021) was discussed and overview of last year's results was presented by Mr. Mohamad Elhage, METAC Coordinator, and METAC advisors. The meeting was chaired by Mr. Alain Bifani, Director General of the Ministry of Finance of Lebanon, who noted that despite the complex political transformation and difficult security situation in the region, METAC had relatively a successful year. Mr. Bifani urged member countries and donors to continue to support METAC financially. Representatives from the IMF headquarters shared their departments' technical assistance (TA) strategies for the Middle East and North Africa (MENA) region. A representative from the European Commission (EC) discussed macroeconomic developments in the MENA region and the EC key reform priorities.

### **Technical Assistance Missions**

#### Revenue Administration

A METAC short-term expert visited the Palestine National Authority (PNA) Department of Customs to assist in defining the future role and structure of the Risk Management and Intelligence functions, based on international good practice.

#### Statistics

A METAC mission for Afghanistan was conducted in Jordan, jointly with the IMF Statistics Department, to assist the Central Statistics Organization of Afghanistan in improving the national accounts. The mission assessed the compilation procedures and provided recommendations to enhance and better use the available source data, and to update the methodological basis of the compilation procedures towards the requirements of the international standards.
