Workshop on the "Future of Banking Supervision Beyond the Financial Crisis"

**T**wenty one participants from METAC and non METAC countries participated in a workshop on the "Future of **Banking Supervision Beyond the** Financial Crisis", which was held from March 2-5, 2010 at the Crown Plaza hotel in Beirut. The workshop aimed to help countries in setting strong foundations for banking supervision, discuss initiatives taken by the Basel Committee and issues related to consolidated supervision. The workshop examined whether there would be a need to go back to classical banking and to the "core principles for effective banking supervision".



The workshop was animated by Mr. Mohamad Ali Hassan, METAC's banking supervision advisor, as well as two international experts: Messrs. Richard Nun and Peter Hayward.

### **METAC Evaluation**

A-recent independent external evaluation found that METAC has been delivering technical assistance (TA) services that are generally effective and highly appreciated by beneficiary countries.

The strengths of METAC are: a firm rooting in the IMF's well established procedures and quality control, a strong regional base, and a network of experts able to work effectively in the region including in Arabic. In addition, the evaluation found that METAC is responsive to country needs, and its activities are strongly integrated with and complementary to IMF's priorities. It was also found that METAC is a principal supplier of TA in the region in many of its technical areas, and that its regional presence and link to the quality control and supervision activities of the IMF provides it with a comparative advantage.
