### **Customs and Tax Administration** in Lebanon

As part of METAC's work program for FY2012, Mr. Martin Brown, METAC short-term expert, visited Beirut during September 13-24 to support the modernization plans of the customs administration. The mission reviewed customs reform implementation, provided technical advice in relevant operational areas, and assessed the needs going forward.

Also Mr. Richard Teed, FAD short-term expert started a mission to Lebanon on September 26 to review the compliance management schemes of the banking sector and train staff in the Large Taxpayers' Office (LTO) on efficient compliance methods and audit techniques.

Ms. Manal Assir, METAC Revenue Administration Advisor, participated in both missions. The authorities praised METAC's assistance in the modernization of revenue administrations and agreed with the missions' findings and recommendations.

#### **Arab Investment Conference**



Mr. Saade Chami, METAC Coordinator, participated in a panel discussion on the impact of regional disturbances on the economies of the region in the context of the Arab Investment Conference, organized by Arab General Union of Chambers. Mr. Chami gave a brief overview of the global and regional economic outlook and discussed in general terms the impact of the regional unrest distinguishing between oil exporting and oil importing countries. Oil exporters have sufficient resilience to weather the global slowdown with the main risk being a fall in the oil price. For oil importers, with a limited fiscal space, Mr. Chami stressed the need for striking a good balance between increasing social spending, to mitigate the impact of higher prices on the less privileged, while at the same time maintaining macroeconomic stability.
